

*Jon Wallenkamp stated that all paperwork has been submitted to the State, and he is expecting to receive their review this week. *Engineer Barbeau stated that a public hearing was held on this matter last Tuesday. The rezoning request is for potential development of the land at a future time. There were concerns from residents of the Hawksnest subdivision primarily related to the development, the berm and water issues that have occurred in the past. The homeowners would prefer not to have traffic come through their subdivision. The density from the town's land use plan has set the maximum number at 11. The minimum area required under the R-1A district is 1 acre. The proposed 11 lots range from 1.0 acre to 1.47 acres. He stated that issue before the Board this evening is only to approve the rezoning.*


